YOUR DAY-BY-DAY ITINERARY

DAY 1 DEPART ATLANTA - We depart from Atlanta for our journey to Greece. Dinner and breakfast will be served on flight.

DAY 2 THESSALONIKA - Upon our arrival in Thessalonika; a city that is over 2300 years old. It was built in 316 BC by Kassandros, the Macedonian King, and was named after his wife, Thessaloniki the sister of Alexander the Great. It was to the church here that Paul wrote his letter to the Thessalonians. Later the city flourished under the Byzantine Empire. Our tour includes the Roman Market, theatre and baths, Arch of Galerius, the city walls, Chain Tower and Citadel, the white tower, Byzantine churches, the cave and well of the Apostle Paul, House of Jason, Monastery of Vlattadon, Aristotle's Square, and statue of Alexander the Great. Dinner and overnight in Thessalonika. (D)

DAY 3 THESSALONIKA - Today we visit the beautiful town of Kavala, called Neapolis in the days of Paul (Acts 16: 11). From here continue to the site of ancient Philippi where Paul started to preach the word of God to the nations and baptized the first Christian on European soil. We see the Baptistry of Lydia, the ancient theater and visit the place where Paul was flogged and imprisoned. Dinner and overnight in Thessalonika. (B,D)

DAY 4 KALAMBAKA - We drive to Veria (ancient Berea), where the Christian congregations were devoted to Paul's works. We stop for a visit at the monument dedicated to the Apostle. Then we continue to Kalambaka to visit the famous monasteries. Perched atop soaring cliffs, gigantic rocks have been etched by time into a variety of shapes rooted deeply in the ground yet completely isolated from the world around them. The Monasteries with their wooden galleries and corniced rooftops hang precariously over the breath-taking abysses, with the Pindus range at their back. We return to Kalambaka, for dinner and overnight. (B,D)

DAY 5 ATHENS - After breakfast we depart, through the mountainous Greek countryside arriving in Delphi, the center of the ancient world - the "Omphalos" ("Naval - of the Earth") whose prestige extended far beyond the boundaries of the Hellenic universe. On the slopes of Mount Parnassus, a landscape of unparalleled beauty and majesty lay the ruins of the Sanctuary of Apollo pythios. Visit the treasury of the Athenians, the temple of Apollo and the museum containing such masterpieces of ancient Greek sculpture as the bronze Charioteer and the famous athlete Aghias. Continue to Athens for dinner and over-night. (B,D)

DAY 6 ATHENS - City sightseeing includes a visit to the world-renowned Acropolis, with the ruins of the Parthenon, Erechtheum and Propylaea. Then, we ascend Mars Hill, where Paul preached (Acts 17:16, 22). Also, view the Agora (ancient marketplace, and former center of Athenian public life), the House of Parliament, the Tomb of the Unknown Soldier and the Presidential Palace. We then depart for Corinth with a brief stop at the Corinth Canal, which separates Peloponnese from the Greek mainland and connects the two seas (Ionian and Aegean). We arrive in Corinth and visiting the site that was home for St Paul for eighteen months. We visit the Archaeological Museum, the Bema, the Market Place, and the Temples. From the Bema at Corinth, Paul spoke to the Corinthians about our Lord and Savior Christ. Return to Athens for dinner and overnight at our hotel. (B,D)

DAY 7 ATHENS - Today we have a full day at leisure to pursue personal interests. Perhaps a visit to the Plaka to shop or eat in one of the many fine restaurants. (B,D)

DAY 8 - ATHENS/ATLANTA - Today our journey ends with good memories as we bid farewell to our new Greek friends. We are transferred to Athens airport for our flight home. Arrival the same day. (B)

ORTAKE THE OPTIONAL AEGEAN ISLES CRUISE

DAY 8 - MYKONOS - Transfer to the port of Piraeus for embarkation on our cruise ship. Enjoy the many shipboard activities or just relax while sailing to the Island of Mykonos with its jet-set atmosphere, whitewashed buildings, sidewalk cafes, 360 churches and chic shops. Here we will see the Archeological Museum and Temples. (B, L, D)

DAY 9 - EPHEBUS/PATMOS - This morning we arrive in Ephesus to visit the "Seven Wonder of the Ancient World" It is here Paul spent many years and wrote his Letter to the Ephesians. Then sail to the island of Patmos and visit the Monastery and the Grotto of St. John the Divine. It is here John wrote the Book of Revelation. (B,L,D)

DAY 10 - CRETE/SANTORINI - We arrive in Crete where Paul and Titus visited in support of the Early Church. We will have time to visit the fantastic ruins before sailing to Santorini one of the most beautiful islands in the Mediterranean. There will be time to walk the cobble streets. (B,L,D)

DAY 11 - ATHENS - Day of Leisure

DAY 12 - ATHENS/ATLANTA - This morning we are transferred to the airport for our flight home. Arrival the same day. (B)

TERMS AND CONDITIONS

Tour prices: All prices in this brochure are based on airfares, land rates and exchange rates in effect at the time of printing and on group rates of 30 passengers or more. Tours may depart with less than the required number of passengers, at the discretion of Group IST, LLC (doing business and referred to therein as "Journeys Unlimited"), but an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations, changes in fuel prices and/or unforeseen economic circumstances.

Reservations, Deposits and Final Payments: Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per person deposit plus applicable (optional) insurance. Receipt of your deposit shall act as your agreement to these terms and conditions. Balance is due 60 days before departure date. If final payment is received less than 60 days, a late fee will be assessed in the amount of \$50.00. If final payment is made by credit card (American Express, Visa, MasterCard), Journeys Unlimited requires a completed credit card authorization form. All payments made by check should be made payable to Journeys Unlimited.

Late Reservations: If a booking is made within 60 days of departure, full payment plus applicable taxes and optional insurance is due at the time of booking. There will be a \$50.00 late processing fee applicable plus cost of any express or overnight mail services. No personal checks will be accepted with reservations received 30 days or less before departure date. Money order, bank check, certified check or credit cards (American Express, Visa, and MasterCard) will be accepted.

Travel Documents: A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for US passport holders traveling to some destinations; please contact our office for details. All non-US citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition, non US citizens are responsible for complying with requirements for re-entry into the USA. Journeys Unlimited assumes no responsibility for procurement of passport or visas. Obtaining and carrying these documents is the sole responsibility of passengers. Journeys Unlimited will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation.

Final Documents and Tickets: All documents and tickets are only issued upon receipt of final payment and are sent within 3 weeks of departure. Documents and tickets are not guaranteed if final payment and booking form are not received on time.

Air from Home City: All brochure departures are based on a New York area airport. Journeys Unlimited can help arrange air transportation from your home city airport. Journeys Unlimited is not responsible for any penalties incurred on domestic tickets not purchased from us, in case of changes in the schedule of the tour. If you are making your own domestic airline tickets, please make sure that your domestic flight time arrives at least 4 hours prior to your international departure time.

Air Changes, Cancellations & Refunds: Airline tickets issued by Journeys Unlimited are highly restrictive and in most instances cannot be reissued, revalidated or exchanged. If a change is possible, a \$75 per person administrative fee, plus any applicable airline change fees, will be assessed once air tickets have been issued.
